A. PURPOSE AND SCOPE

1. To outline procedures to be followed when a district staff is notified of a registered sex offender.

B. LEGAL AND POLICY BASIS

- 1. **Reference:** Board policy C-2200, H-8900, I-1350, I-1400; Education Code Sections 32211, 35160.1; Penal Code Sections 290, 290.4, 626.8; 626.81;U.S. Code Title 42, Section 14071.
- 2. In order to protect and ensure the safety of students, the Board of Education recognizes that the district should interact with law enforcement when contacted about registered sex offenders who may reside or work within district boundaries. The superintendent or designee shall establish ongoing relationships with law enforcement officials to coordinate the receipt of such information and establish procedures for notifying appropriate staff, students, and parents/guardians as necessary.

C. GENERAL

1. **Originating Office.** Questions and suggestions concerning this procedure should be directed to the School Police Services Department, Office of the Superintendent.

2. **Definitions**

- a. **Notification**: An official written notice from a law enforcement agency that a "high risk" and/or "serious" sex offender resides or is employed within district boundaries. Verbal information is not an official notification.
- b. **High risk/serious**: A person who has been convicted of multiple violent offenses and has been identified by the Department of Justice as having a higher risk of re-offending and who may pose a greater danger to the public.

c. **Lawful Business:** A reason for being present upon school property which is not otherwise prohibited by statute, by ordinance, or by any regulation adopted pursuant to statute or ordinance.

D. IMPLEMENTATION

- 1. **Notification:** The district's first priority is the safety and welfare of its students. If any district staff receives an official notification concerning a registered sex offender, the following procedure should be followed:
 - a. Contacts School Police Services Crime Analyst at (619) 725-7009 to ensure the information is correct and that the registrant resides and/or is employed within the boundaries of the district.
 - b. Informs certificated and classified personnel (who are located in the attendance area of the registered sex offender's residence/place of employment) to report any possible sightings of the registered sex offender on or nearby school grounds to School Police Services immediately.
 - c. Contacts Legal Services at (619) 725-5630 to determine if further notification outside of the district is appropriate.
 - d. If outside notification is recommended, the principal of the school (which is in the attendance area of the registered sex offender's residence/place of employment) may institute a mailing notifying parents/guardians of the information. Principal includes a letter prepared by law enforcement and printed on law enforcement letterhead encouraging parents/guardians to contact local law enforcement for additional information.
 - e. Verbal notifications from parents/guardians, staff, or other community members are not official notifications, and therefore should not be immediately acted upon. In these cases, the principal of the school (which is in the attendance area of the registered sex offender's residence/place of employment) may contact Legal Services for further guidance.
 - f. In a rare case in which the offender is a juvenile attending school, contacts Legal Services for further guidance.
 - g. Registered sex offenders are permitted on school grounds only if they have lawful business at the school <u>and</u> written permission from the chief administrative official of the school. (Penal Code 626.81). If a registered sex offender is the parent/guardian of a child attending the school, he/she must request permission of the site principal and receive written permission prior to coming on school grounds. The site principal may deny or limit school access

and may develop a plan which strictly limits the registered sex offender's access to the school campus, such as requiring the registered sex offender to remain in his/her car when dropping off his/her own child at school.
